Prior to drafting any contract for goods and services, the responsible party or the decedent's survivor who is handling the arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

There is no evidence that any casket represented as having protective features, which may include a gasket, will preserve human remains.

CREMATION SOCIETY OF SANTA BARBARA DIRECT CREMATION SERVICE PACKAGE

(includes merchandise) \$ 1,395.00

This package includes the basic services of the funeral director and staff, a transfer of the body from the place of death (within 10 miles of Santa Barbara city limits, SECOND ATTENDANT FOR TRANSFER COULD BE ADDITIONAL DEPENDING UPON TRANSFER SITUATION OR REQUIREMENTS) to refrigerated holding facility and cremation facility, minimum preparation of the deceased with positive identification, filing of death certificate with County, minimum cardboard cremation receptacle, the actual cremation process, and the basic durable plastic economy urn.

Itemized Selections

The services and merchandise shown below are those we can provide to our customers. You may choose only the services and merchandise you desire. However, any cremation arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any services or merchandise you did not specifically ask for, we will explain the reason in writing.

SERVICES

Basic Services of the Funeral Director and Staff \$ 650.00

This charge for our basic services and overhead will be added to the total cost of the cremation rearmaments you select. This fee is already included in our charges for direct cremations. This charge includes but is not limited to, availability of staff 24-hours a day, staff and facilities to respond to initial request for services, consultation with responsible party to determine services desired, coordinating service plans with cemetery, crematory and/or other parties involved in final disposition of the deceased, filing local death certificate, obtaining local disposition permits with the health department.

Transportation within City of Santa Barbara or with 10 miles of city limit \$595.00 Transportation within Santa Barbara County – an additional \$595.00 Second Transfer Attendant when required (per attendant) \$350.00 Transportation Charges: Ventura or San Luis Obispo County \$795.00 Transportation: All other counties in California require a quote

Use of Refrigeration / Holding Facility \$125 (for the first 5 days)

Use of Licensed Climate Controlled Holding Facility (beyond 5 days) \$50 per day

Pacemaker / Device Removal prior to cremation \$ 200

Private Identification Viewing private identification viewing for up to 3 people for 15 minutes in our Parlor or ID Room \$295.00

Crematory/Cremation Fee (for decedents weighing less than 250 pounds) \$311.50 From 250 to 350 pounds \$300 surcharge

Additional Cremation Fee for decedents weighing over 350 or more pounds requires a quote.

Delivery of cremated remains to cemetery or residence (in Santa Barbara City) \$395

Packing and shipping cremated remains via US Postal Service Registered Mail/return receipt required (within the continental United States) \$250

After hours charge for Weekends/Holidays/Evenings *Outside of between 9am to 5pm \$500 Rush Cremation Fee (FOR MOST EXPEDICIOUS CREMATIONS) \$650

MERCHANDISE

Minimum Alternative Container made of Heavy Cardboard Required for Cremation \$125.00 Air Tray with sturdy wood base for cases over 250 lbs. \$295.00

CASH ADVANCES

Cash advance items, such as cremation permits (\$12.00 each) and certified copies of death certificates (\$24.00 each), will be charged at cost.

All charges are due and payable in full prior to completion of the cremation.
